Refund Policy: Your AAA Club takes special measures to be prepared to handle all Emergency Road Service calls. However, during periods of extreme weather or in isolated cases where AAA Service may not be available or many miles away, members may obtain help from the nearest available garage. Submit the original receipt along with this completed refund application **within 30 days** for refund consideration. When a member is entitled to a refund, it will be made in an amount equal to the cost of a similar call rendered by an Official AAA Station at Club rates. **This application must be fully completed before a refund can be considered.**
